EDUCATION SITUATION IN ESTONIA

- 1.3 million people in Estonia
- Ca 24 000 teachers:
 - + 8 000 kindergarten teachers
 - + 14 000 school teachers
 - + 2000 VET teachers
- Good education has always been very important
- Today teachers are not sufficiently valued (TALIS) EEPU is working on this problem (salary, work load etc)
- We have good results in PISA tests it shows the good work of our teachers ©
- We have good network of strong comprehensive schools

PRIVATISATION IN EDUCATION IN ESTONIA:

- Historically there have been almost no private schools in Estonia:
 - + 1920 1940 only state schools
 - + 1940 1990 Soviet Union no private schools
 - + 1991 all scools state scools or local authorities scools
 - + 1991 2010 only few private schools They were all either owned by the church or used an alternative form of pedagogy (33 private schools)

PRIVATISATION IN EDUCATION IN ESTONIA:

- 2011 new law local authorities must pay more costs
 - + 2011-2015
 - +50% private schools (49 private schools)
- That is not a big problem in Estonia, yet.
- 2015 (2016) new (old) law it is not mandatory for the local authorities to pay the cost of the school building (they can do it if they want to)
- We (the EEPU) think thats a good idea!

- This document describes the current situation in major areas of education. It also lists the goals to reach by 2020 and the financial (ESF) resources needed to reach these goals.
- Different parties were involved in developing Estonian Lifelong Learning Strategy (EEPU, head masters etc.)

ESTONIAN LIFELONG LEARNING STRATEGY 2020 MAIN OBJECTIVES

- Average salary of teachers should be raised to be 120% of the average salary in Estonia.
- The two priorities are developing digital learning materials and ensuring adequate infrastructure
- Another priority is to increase participation in vocational education and training, and its labour market relevance.
- Apprenticeship-based vocational education. It is a form of vocational education where schools cooperate with different companies and most of the learning takes place at the workplace.
- Estonian Lifelong Learning Strategy 2020 is an impotant document.

THE EEPU AT THE MOMENT:

- According to the law, we negotiate the salaries of teachers with the minister of education every year.
- This year the negotiations have been quite tricky.
- The goal is to raise the salary of teachers to 120% of the average salary in Estonia.
- This aim is also in our coverment coalition agreement, so we hope that we will be able to come a bit closer to this goal next year as well.
- It will not be easy but we're working on it.
